Dear Director Kane:

Pursuant to section §1060.20.3(e) MPC, the Department is requesting a Suspension for Public Safety by the Director. The Department is confident that the below listed exhibits meet or exceed the requirements of §1060.20.3(1)(a). As such we respectfully request that your Commission act positively on our recommendation and suspend the premises Entertainment Permit for 72 hours.

Report Title: Firearm, Discharging at Unoccupied Bldg, Vehicle or Aircraft


**Synopsis:** Officers were standing in front of **Atmosphere Night Club** at 447 Broadway when numerous fights broke out directly in front of the club. As officers were dealing with the fights (see 141-046-856), shots were fired near 350 Broadway. Two bullet holes were located in an unoccupied car, six casings were located as well as blood splatter on the street. Interviews were conducted after the incidents and an individual who identified himself as an off duty MTA Sergeant stated that he had been in **Atmosphere** when physical fights broke out inside the club. He stated that a girl in a white dress was causing the problems. He heard numerous people yelling, "They got guns." The off duty MTA Sergeant saw two black males brandish firearms inside the club. It was at this point that he ran out of the Club. No victim of the shooting was located or reported.

Report Title: Resisting Peace Officer, Causing Serious Injury or Death, Probation Violation, Warrant Arrest, Enroute to Outside Jurisdiction

Synopsis: Officer's were in front of **Atmosphere** when they heard a loud altercation coming from the front door of the Club. Security was attempting to separate several individuals as they walked towards the entrance. One of the individuals who was yelling, screaming, and attempting to fight was Booked- Galasi a known member of the 800 Block Gang in the Western Addition (he is also a known Rapper under the moniker of Frost and a promoter). A full uniformed Police Officer approached Galasi and instructed him to sit down and calm down. Galasi continued to yell and scream at individuals in front the club. Galasi had his hands clinched and appeared to be continuing to provoke people and start a fight. The Officer attempted to control Galasi and Galasi began to pull away from his grasp. Galasi was subsequently taken to the ground by the Officer's assisted by other Officer's. Galasi continued to resist and disobey orders to stop. After a brief struggle Galasi was cuffed by the contacting Officer. As a result of Galasi's resistance and struggle with the Officer's the contacting Officer sustained a non-displaced fracture to his left wrist.

Synopsis: An individual was ejected from **Atmosphere** by Staff Security. As the suspect walked away with his girlfriend he picked up an unknown object and threw it at a uniformed Police Officer. The Officer approached the suspect to detain him and the suspect struck the Officer in the face resulting in a left eye contusion and a fractured right finger.

**Report Title:** Battery


**Synopsis:** Officer's noticed two male individuals struggling just to the left of Atmosphere. One suspect was striking the other to the head and shoulders with his cellular phone. One individual was bleeding from the face and mouth. As Uniform Police Officers engaged the two, the primary aggressor resisted the Officer's resulting in the two Officer's and the suspect falling to the ground. One of the individuals later told the Officers that the fight started inside Atmosphere.

The above listed incidents are a small sampling of the ongoing problems in and around Atmosphere Club. These incidents were specifically chosen due to the contemporaneousness of the incidents (Exhibit A) as well as all of the incidents (Exhibit A and B) meeting the requirements set forth in §1060.20.3.(1) (A) MPC.

As a result of this continued pattern of violence, injury to our public, and the Licensees' inability to improve the safety of his premises the Department recommends an immediate Suspension for Public Safety by the Director
